# 3. Cofnodion o'r cyfarfod gynhaliwyd ar 26<sup>ain</sup> Gorffennaf 2021 / Minutes of the meeting held on 26<sup>th</sup> July 2021

3.1. Item 15.3 should read Christmas lights, not Christmas slights. Clerk to rectify this. Subject to the above amendment, Cllr. Lewis proposed that the minutes are correct and approved, Cllr. Williams seconded, all agreed.

- 4.1. Item 14.1 re cost of play area repairs in the past few years. The Clerk has sent this figure to everyone.
- 4.2. Item 17.2 re signed Field in Trust document. This has not been received yet. Clerk to chase this up.
- 4.3. Item 26.4 re accessing OS maps for the Biodiversity officer. The Clerk has sent 2 registration emails but the officer has not signed up.

#### 5. Adroddiad y Cadeirydd / Chair's Report

5.1. The Clerk received an email from R. McGarry which was sent originally from Sue Leonard at PAVS. This email arrived too late to put on the correspondence list. The Forum have agreed to re-advertise for the ERO post. The town council previously agreed to be part of the steering group and Cllr. Williams proposed that the town council agree to continue to be part of this group, Cllr. Davies seconded, all agreed. Cllr. Williams proposed that the full email be discussed at the next meeting.

5.2. Cllr. Williams has been looking at outdoor table tennis equipment for Parc y Plant. This to be put on the next agenda.

# 6. Trafod lleoliad cyfarfodydd yn y dyfodol / Discuss location of future meetings

6.1. The Clerk has emailed everyone her thoughts on this and suggested that the council continue with online meetings for now, as hybrid meetings will be very hard to manage. OVW have recommended either councils meet online or have hybrid meetings. All councillors agreed with the Clerk.

9.1. <u>Sand in play area</u> – Cllr Letten has rotovated this area but this will need to be done again soon. He has had contact from Preseli fencing who is waiting for delivery of a replacement part. Cllr. Williams has been in touch with the Headmistress to ask parents to contact the new Grants & Projects officer regarding grants to refurbish the play area.

## 11. Tendr goleuadau Nadolig / Christmas lights tender

11.1. The Clerk confirmed that she has received one tender and opened it. The tender is from DN Wilmott. Cllr. Davies asked what the budget was for the Christmas lights work, the Clerk confirmed the council has budgeted £3,500. The quote received is no more than this. Cllr. Letten proposed that the tender is accepted, Cllr. Davies seconded, all agreed.

## 12. Arolwg ac anghenion Tai / Housing and needs survey

12.1. Cllr. Williams reported that she and Cllrs. Davies and Harries met with the Welsh Government regarding the housing pilot scheme. Keith Edwards, consultant for the housing and needs survey has interviewed 7 members of the community and has a further 15 people to talk to. Keith has advised that he would like to talk to people under 30, people over 70 and social renters and people who were born here to make sure he is including all the different types of people in the community. Clerk will share the poster again on Facebook.

- 24.1. The accounts are as follows: Treasurers-£39,514.68, 30 day savers-£21,237.62, Grants & Projects-£5,307.04. The Clerk advised that the Arborculture invoice be paid from the Hedges and trees reserve, the Brynhyfryd hay cutting invoice to be paid from the cemetery reserve, Cllr. Paul Harries payment to come from the budget, ArbWales invoice from the cemetery reserve and the street market licence to come from the budget. Cllr. Davies advised that the monthly payment to the GPO needs to be on the agenda, Clerk will do this from now on. Cllr. Davies proposed that all finances are paid, Cllr. Letten seconded, all agreed.
- 24.2. <u>Discuss and agree on reserve allocations</u> this to be put on the next Budget & Finance agenda.

- 24.3. <u>Victoria Gardens ownership and lease</u> Cllr. Griffiths has sent an update to everyone. In 1999 the Welsh Government put in a claim. Cllr. Griffiths will draft a letter to the Welsh Government for further information.
- 24.4. <u>Update on planning application on behalf of the playing field for a container on the playing field</u> this has been accepted and been sent to the Clerk to be put on the planning agenda.
- 24.5. <u>ArbWales, Visual tree assessment survey in Brynhyfryd cemetery</u> discussed in item 20.3.
- 24.6. <u>Extra burial plot row in Brynhyfryd cemetery</u> The Clerk met the gravedigger at Brynhyfryd cemetery who advised there is room for a single row of burial plots. The council agreed that there is no need for this extra row of plots for now and will keep this suggestion on hold for now.

Lloyd proposed that a town council community asset working group be set up, Cllr. Davies seconded, all agreed. Cllrs. Davies, Morgan Lewis, Letten, and Williams volunteered to be on this group. The Clerk to send an email to all councillors asking if they want to join.
