In accordance with the Town Council business plan for the CAT of Canolfan Croeso, we included the building of an extension to the rear for the community and town council use. In order for this to happen and for the use of the extension, we need to ensure that we have a guaranteed right of way over the land contained in the passage down the side. John Griffiths obtained the Land registry documents, which showed it is owned by Tabernacle. The owner of Chapel House (the house behind, which is solely accessed down that path) has recently died and the ownership of that property will be passing on to the beneficiaries, who may decide to sell the property. It is possible that we may encounter difficulties in future with the use of that passage for building work and access unless our position is clarified.

3. Considering each asset, its potential use for the community and ways to proceed 3.1 The group considered the current position regarding land to the east of Pen Y Bont. This land is prioritised for housing. The group discussed whether the Town Council could consider buying the land in order to provide affordable housing for local people, either to buy or to rent. This would require a loan, and any business plan would need a source of income in order to pay this off.

4. Proposal on how to proceed

4.1 The Working Group requests that the Council discuss and decide on the following proposal.

a) Find out if the land is, or will be, for sale, and if so what is the asking price.

b) Approach Pembrokeshire County Council for advice and help on financing such a purchase.

c) Approach Housing Associations and the Community Housing Association for information and advice.

d) Investigate other sources of finance
