Its location is clearly set within the chapel grounds which wrap around its side and rear curtilage. There is a lack of any physical separation or boundary feature, other than the retaining wall from the chapel grounds.</p> <p>That being the case, Newport Town Council requests sight of the Conservation Officer's report before making a recommendation.</p> <p>The applications will be reconsidered and a recommendation submitted once the report has been received and considered.</p> <p>Recommendation:-</p>
