The Project Manager has asked for further information on this and has expressed concerns of possible duplication of their effort in their project. Cllr. Davies has drafted responses to both emails and sent to all councillors for their comments. Cllr. Barrett proposed that these 2 emails are sent to all recipients of the emails and also the Forum coordinating committee, Cllr. Lloyd seconded, all agreed.

11.1. The Clerk has sent out the draft review of the inventory of land and assets. The bus shelter at the bottom of Ffordd Bedd Morris appears to be owned by the Welsh Gov as does Newport square. The lease for Parrog shelter is still under negotiation. Cllr. Varney reported that some members of the community had queried that the Boat Club have fenced off the area around the Club. Cllr. Griffiths advised that this is a matter between the Boat Club and the Barony. Members of the community can contact the town council regarding this issue and the Clerk can then forward these queries to the Barony. The Clerk has updated donations to charities for 2021/21. Cllr. Harries proposed that the land and assets document is accepted, Cllr. Williams seconded, all agreed.
