3.1. Cllr. Lloyd proposed that the minutes are correct and approved, Cllr. Griffiths seconded, all agreed.

7. Adroddiad y Cadeirydd / Chair's report

7.1. The Chair and Clerk have received a late email from the Mayors Committee, requesting a financial donation of £300 to purchase coronation commemorative mugs. This request was too late to be put on the agenda. The Chair can use discretionary powers to approve financial payments up to £500. The Clerk advised that this was a very late request and that all financial considerations should follow procedure and be on the agenda. Cllr. Harries advised that he uses his discretionary powers to agree to this financial request.

8. Tan-gynnig arfaethedig i Ganolfan Gwybodaeth Trefdraeth (CGT) / Proposed underlease to Newport Information Centre

8.1. <u>Consider submitting the notes to RedKite Law with the Council's comments and requesting</u> <u>Red Kite Law for advice prior to responding to CGT (Newport Information Centre)</u> – Mark Taylor has prepared notes. All agreed with these notes. Cllr. Griffiths proposed that he compose an email to be sent to Red Kite solicitors, Cllr. Lewis seconded, all agreed.

9. Lloches bws Castell / Castle Bus shelter

9.1. <u>Discuss matter of owner of the Bus shelter and adjoining land (to whom the Council pays</u> <u>an annual rent of £5) wanting to sell the land to the Town Council</u> – Cllr. Griffiths has spoken to the estate agent regarding an evaluation on this land and advised that the council should go into a private session to discuss this information. This to be put on the agenda for the next meeting. Cllr. Griffiths to circulate a brief outline of what has been discussed.

11.1. The Clerk has drafted a plan and circulated to all councillors. Cllr. Harries proposed that the training plan is approved, Cllr. Lloyd seconded, all agreed. This document to be put on the website.

12.1. The Clerk to follow this up with Telemat. Keep on the agenda.

13. Strategaeth toiledau cyhoeddus / Public toilet strategy

13.1. A letter of consideration by Newport Town Council of the future provision of public toilet facilities has been sent to various people. This letter to be put on the website and Facebook page. County Cllr. Huw Murphy reported that he has submitted a full notice of motion for the next PCC meeting asking that the toilets stay open until March 2025. Cllr. Harries proposed that the town council support Huw Murphy's notice of motion that proposes to retain the toilets until March 2025, Cllr. Letten seconded, all agreed.

14. Swyddi gwag cynghorwyr / Councillor vacancies

14.1. The Clerk confirmed that the co-option posters have gone up in the noticeboard, on the website and Facebook page. The deadline is 29th May.

15. Adroddiad arolwg tai / Housing survey report

- 15.1. <u>Task and finish group</u> notes of the last meeting have been circulated. Some work needs to be done before the next meeting is called. The Clerk has been collating paperwork to send to PCC to receive the Enhancing Pembs grant. The Clerk to liaise with Cllr. Lloyd to call the next meeting. County Cllr. Huw Murphy has emailed the council with a report on PCC housing waiting list numbers. It looks like that if someone within PCC puts Newport down as a preferred location and puts another 3 towns in e.g., Haverfordwest, Milford and Fishguard then they appear in need on all 4 locations, when it is only 1 person/family. In a nutshell an applicant has a greater chance of being matched with a property if they say there are prepared to live in a number of locations. If this is true it skews the housing needs altogether and is not a true reflection of the housing needs of any town/village. The Clerk to send this email to the task and finish group.
- 15.2. <u>Calling a public meeting</u> this to be considered at the next meeting.

16. Dogfennau llywodraethu / Governance documents

- 16.1. <u>GD12 Services</u> remove no 7 which states Parrog yard as a service, change no 5 to Newport playing field instead of Rugby field and list the Football pitch as a service, include Unit 3 as a rental space. Cllr. Letten proposed this document is approved, Cllr. Lewis seconded, all agreed.
- 16.2. <u>GD20 Computer access protocol</u> Cllr Harries proposed this document is approved, Cllr. Lewis seconded, all agreed except for Cllr. McGarry who had left the meeting briefly at this point.

17. Materion yr amgylchedd / Environment matters

- 17.1. <u>Climate Emergency statement</u> The Clerk has received NALC information and will circulate it to all councillors. Cllr. Harries advised that the statement could state "Cut climate damaging pollution locally in line with global targets, whilst developing resilience to more extreme weather patterns and rising sea levels." Keep on agenda.
- 17.2. <u>Tree planting project/Brynhyfryd tree survey report and estimate cost of</u> works Cllrs. Griffiths and McGarry met with Liam Morris who will email the Clerk with information.
- 17.3. <u>Crown reduction on trees by Parc y Plant/Pen y Bont</u> Clerk has received an invoice for this work. Clerk to enquire what has happened to the wood from this tree.
- 17.4. <u>Consider Dwr Cymru meeting invitation</u> Cllr. Harries has received an official response from Gwyn Thomas at Dwr Cymru regarding the recently reported sewage incident. This response to be put on the website and Facebook. Cllr. Bayes stated that an incident had been shared on Facebook recently. Cllr. Harries confirmed that a similar incident occurred a few years ago and that the froth on the beach is mainly not pollution, it is naturally occurring. Kelly Jordan from Dwr Cymru is happy to meet with the council. Cllrs. Harries, Bayes and Lloyd volunteered to meet with her. The Clerk to set up this meeting.

- 18.3. <u>Financial appeal for a bilingual music website which is free and available to all</u> <u>promoters of music within a reasonable distance of</u> Newport – Cllr. Harries proposed that this request is not funded, Cllr. Lewis seconded, majority agreed, 1 abstention.
- 18.4. <u>Request for Blue plaque on building to commemorate West Wales Eco</u> Centre Request received from B. John for a bilingual blue plaque to be placed on the old school building stating that on this building the first and smallest commercial solar PV installation in the UK started to feed electricity into the grid, 11th October 1966. The building is owned by PCC. County Cllr. Huw Murphy will investigate this. The Clerk to send him the request.
- 18.5. <u>PCNPA 70th anniversary tree planting project</u> the town council suggested trees could be planted either side of the entrance to Newport. Cllr. Harries has spoken to Richard Bros who do not want trees planted opposite the garage. Cllr. McGarry questioned whether they own this land or does the Trunk Road agency or landowner of the field own it? Keep on agenda for re-consideration.
