Mr. Watkinson stated that 4 challenges to the public rights of way have now been challenged. This information has been sent to all councillors via an email from Mr. Watkinson. Mr. Watkinson would like the town council to endorse their application to register specific historical rights of way to Carningli common on the Definitive Maps of Public Rights of Way.

Cllr. Griffiths advised that the council's standing orders prevent the reopening of the discussion for 6 months so that the Watkinsons would have to persuade the Council that there had been a significant change of circumstance under the wording of the earlier resolution to justify the Council reopening the discussion. The council were aware of the 4 challenges when the decision was made in the February meeting.

Cllr. Griffiths stated that the notice, put up in 2020 that says 'that the use of the way is by permission of the landowner' is concerning. Cllr. Lewis agreed with these concerns. Cllr. Harries stated that PCNPA had sent an email saying they are currently replacing the pedestrian gate. Cllr. Harries has walked this path numerous times over the last 50 years and would not want to see the rights of way eroded. Cllr. Lloyd advised that the council must be careful not to take sides whilst this court case is ongoing.

Cllr. McGarry stated that she personally thinks that there has been a change of circumstance, Cllr. Letten agreed and that the outcome of the court decision could be a concern for the wider community.

Cllr. McGarry asked Mr. Watkinson whether he is planning to send in an application to register the rights of way with or without the town council's support. Mr. Watkinson confirmed they would be sending in an application.

Cllr. Harries asked whether PCNPA are aware of the court case? Mr. Watkinson is not sure if they are aware.

Cllr. Griffiths proposed that there has not been a sufficient change of circumstance to justify the town council reviewing the decision made in the February planning meeting, Cllr. Harries seconded; the majority voted in favour.
