Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Newport Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Burial plot reservations

The Council received £1,037 on 4 July 2022 for the reservation of a burial plot. I was unable to find this purchase recorded in the Council's burial records provided for audit. I also noted that a number of entries in the burial records spreadsheet provided for audit were annotated 'Not recorded in purchase of graves book'.

We recommend that the Council reviews its burial records to ensure that the records are complete and accurate.

Approval of setting fees and charges

The Council has not reviewed its burial fees and charges and its market fees in the financial year. The Council should formally confirm on an annual basis all fees and charges set by the Council.
