1. Ymddiheuriadau am absenoldeb / Apologies for absence

1.1. Apologies received from Cllr. Lewis.

### 2. Datganiad o ddiddordeb / Declarations of Interest

2.1. Cllr. McGarry declared a personal interest in item 16.1 and proposed that this item be moved to the top of the agenda, all agreed.

# 3. Prydlesi a chytundebau / Leases and agreements

- 3.1. Land leased to Mr and Mrs. Sneade the 2 representatives of this matter were present at the meeting. Cllr. McGarry asked them if they would like to speak. J. Davies asked whether someone has been out to look at the 2 boundary markings? Cllrs. Griffiths and Lewis have visited the site. M A. Sneade reported that the yellow boundary line has eroded and that the boundary stone has been moved. She advised that the only way to mark the definitive line is to get a GPS surveyor to come and stake it out. Cllr. Griffiths asked whether both parties could compromise on the difference of their boundary lines? J. Davies confirmed he would be happy to accept the boundary between the 2 lines, M A. Sneade advised she is not happy to accept this. MA. Sneade advised that J. Davies has already attained a meter of the land and that the beech hedge should be planted on the white boundary line that has been marked out.
- 3.2. Cllr. Griffiths voiced his frustration at the situation, the trustees own this land which is leased, it needs to be protected, is it reasonable to spend this time and money over a couple of meters? This matter should have been resolved months ago and suggested that the land be put up for sale. Cllr. Harries agreed that he was also disappointed that this matter hasn't been resolved amicably.

3.3. Cllr. McGarry advised that the trustees are not qualified to say where the exact boundary line is. Cllr. Griffiths asked whether M A. Sneade was happy for her latest email, sent to the trustees this evening at around 7pm which has Kathryn Perkins expert report and appendix attached to it be shared with J. Davies. Mrs. Sneade agreed to this. Cllr. McGarry asked J. Davies if he will accept the report? J. Davies stated that if the paperwork shows that the boundary line is the white line marked out then yes, he will accept this. The trustees advised J. Davies to get back to them with his answer within the next 2 weeks. Cllr. Griffiths proposed that the trustees instruct solicitors to advise them to begin the process of disposing of this land, Cllr. Harries seconded, 4 voted for, 3 abstentions. Cllr. McGarry proposed that the trustees contact JCP solicitors, Cllr. Griffiths seconded, all agreed. Cllr. McGarry advised that the land would be sold with the current lease intact. M A. Sneade commented that as the trustees are the landowners of the land, do they not have a responsibility towards their tenant? Cllr. Griffiths advised that the trustees do not have their own expert report to say where the exact boundary line is. Cllr. Harries advised that the trustees have not yet a had a chance to look at the expert report and appendix as it was only received tonight at around 7pm. The 4 members of the public left the meeting.
